Dr. Axel Kaufmann becomes new CFOO & Spokesman of the Executive Board of Nemetschek SE

Deutsche Bank AG and international studies, he earned his doctorate at the University of Paderborn.

Patrik Heider, the former CFOO & Spokesman, is leaving Nemetschek SE by December 31, 2019 at his own request and will pursue his own plans in the future. The Supervisory Board is very grateful to Mr. Heider for his work, his commitment and his achievements over the past 6 years as well as for the material and successful development of the company and wishes him all the best for the future.

Nemetschek SE will publish its business results for Q3/2019 and make further statements regarding this release during the conference call already scheduled for October 31 at 9:30 a.m. CET.
